I. Departments with farm cases since July 2022

13 departments had at least one outbreak: Ain, Dordogne, Ille-et-Vilaine, Indre et Loire, Loire-Atlantique, Maine-et-Loire, Manche, Meuse, Morbihan, Sarthe, Seine-Maritime, Somme, Vendée

The department of Ain, which had regained its free status on 4 October, lost it again with the confirmation of a second outbreak on a farm on 18 October.

The department of Dordogne, which had regained its free status on September 9, lost it again with the confirmation of an outbreak in a farm on 20 October.

Concerning the departments of Meuse (55), Ille-et-Vilaine (35), Somme (80), Indre-et-Loire (37) and Seine Maritime (76), the DG for Food is in the process of finalising the study of the surveillance data in order to lift the restricted zones in the near future, which will allow these departments to regain their free status in the absence of a new outbreak.

19/10: confirmation of a 5th outbreak in Vendée (85) in a farm of 18,500 ducks in the municipality of: SAINT HILAIRE DES LOGES

20/10: confirmation of a 6th outbreak in Vendée (85) in a farm of 12,000 ducks in the commune of: MOUTIERS SUR LE LAY

20/10: confirmation of an outbreak in the Dordogne (24) in a farm of 18,400 future laying hens in the municipality of: LUNAS

• Sarthe (72): 1 new outbreak

Sanitary measures, zoning

As for all outbreaks, as soon as the suspicion was raised, sanitary management measures were triggered within the EU regulatory implemented zoning (3 km Protection Zone "ZP" and 10 km Surveillance Zone "ZS" around the farm): culling of poultry on affected farms (either as a preventive measure or at the latest the day after NRL confirmation), reinforcement of biosecurity measures, census of farms and ban on poultry movements.
